Entry Criteria:

1. Be a UK-registered charity or have tax-exempt status
2. Be registered on BigGive.org (free to register)
2. Submit up to 3 photos* that best demonstrate your charity impact to Big Give

Key Timelines:

Start: Monday, 5th June, 9am

Deadline: Monday, 3rd July, 5pm

Award Announcement: Monday, 31st July

Rewards:

1st place: £2000 from Big Give

2nd place: £1000 from Big Give

3rd place: £500 from Big Give

Terms and conditions:



Entry:

1. You must be a UK-registered charity with a Charity Commission number or have tax-exempt status to qualify and enter The Big Photo Challenge.
2. Submit between one to three photos to Big Give (via the form provided) to confirm your entry.
3. All submissions must be received by COB, 5 pm Monday, 3rd July; any submissions received after this date will not be considered.
4. By entering the competition, you agree to the provisions of these terms and conditions and to comply fully with them.
5. Photographs must be a minimum 1MB – maximum 5MB file. Entries must not have been a 'winner' in any other photographic competition.
6. A maximum of one entry may be entered per applicant
7. An image will be rejected if it appears to have been taken in such a way that law or safeguarding requirements may have been breached or it has been otherwise taken in an irresponsible way.
8. Big Give reserves the right to remove or refuse any entries from the competition for any reason.

Photos:

By submitting images to Big Give's Photo Challenge, each entrant confirms and warrants that:

1. Big Give have permission to use all imagery provided for commercial marketing use, including using across marketing channels;
2. They own the copyright and any other intellectual property rights of each image, and have given provided full credit of the image owner;
3. They have the permission of anyone pictured in the image (or, where the image shows any persons under 18, the consent of their parent/guardian) for the usage rights required by Big Give and will indemnify Big Give against any claims made by any third parties in respect of such infringement;
4. They have received any necessary permissions from the owner(s) of objects, including buildings included in submitted images for the usage rights required by Big Give and will indemnify Big Give against any claims made by any third parties in respect of such infringement.

Judging and Winners:

1. If you are a winner, you will take part in and cooperate fully with reasonable publicity and to the use of your name and photograph in such publicity,
2. Judges will select images based on demonstrating charitable impact, and the decision of the organisers is final. No correspondence will be entered into concerning the competition's judging and organisation.
3. Digital adjustments are acceptable; however, the way in which any digital enhancement or editing has been used will be taken into account when judging the entry. Cropping is allowed.
4. The winning charities can decide if the prize money is given directly to their charity or allocated as match funding in any Big Give campaign ending by 31st July 2024.
